- 3) Shri N. Ganesh, A.O.


After detailed deliberations, following decisions were taken in the meeting:

- 1) Conveyance Allowance of Rs.2000/- each to 3000 beneficiaries of Skill Development Programme for the year 2015-16 were sent through NEFT on 22/07/2016. However, some of the beneficiaries informed that the amount is not credited in their Bank Account.

It is decided that Accounts Section will inform the Names of the Beneficiaries for whom fund could not be credited. SERD will inform the Training Partners accordingly and request them to update the Bank Details and send the same in Notepad Format. All beneficiaries should have their Bank Accounts in Nationalized Banks.

- 2) HOD/SERD (Nodal Officer-SDP) will put up file of Training Partners who have sent the details of placement of beneficiaries (with proof) for release of Post-Placement support for the beneficiaries and also for release of Training Cost on receipt of Test Check report from the organization.
- 3) HOD/SERD informed that as regards proposal for Skill Development Programme of PWDs for the year 2016-2017, in spite of extending the date for submission of **Expression of Interest** (upto 15th September 2016), till date proposals from following nine organizations are received out of which two are not eligible.
 - a) Gana Educational Development Society, Hyderabad, Telengana
 - b) National Youth Project, Itanagar, Arunachal Pradesh
 - c) National Education Society and Social Welfare Organization, Anantnag, Jammu & Kashmir
(Not Eligible as not empaneled by DEPwD, MSJE)
 - d) Deep Vidhya Mandhir Samiti, Dausa, Rajasthan
 - e) Badulara Deeshari Society, Bankura, West Bengal
 - f) Bankshimul Gramin Unnayan Samiti, Bankura, West Bengal
 - g) Nir Ideal Home for Mentally Retarded and Associated Disability, North 24 Parganas, West Bengal
 - h) Jalpaiguri Swapnatoron Welfare Society, Jalpaiguri, West Bengal
(Not Eligible as not empaneled by DEPwD, MSJE)
 - i) Kenduadihi Bikas Society, Bankura, West Bengal
