Dear Parent,

This is with reference to the final university examination of your ward who is studying in MASLP - I at this institute. As you are aware, the institute has tried its best to request the MUHS to not conduct the examinations in view of the COVID19 pandemic. However, MUHS has circulated the final exam time-table for MASLP I from 17th August 2020.

In view of this, the institute is in the process of making all possible arrangements within the given infrastructure constraints and the current situation in Mumbai to provide hostel accommodation for the students who require it. This accommodation is on sharing basis.

The following standard operating procedure (SOP) and protocols have to be followed by the students for entry to the AYJNISHD(D) Hostel.

1. Standard Operating Procedure (SOP):
 - a. Download Aarogya Setu, the mobile application developed by the Government of India on your mobile phone and learn the best practices to prevent COVID-19. Keep mobile application active during the entire period of stay at AYJNISHD(D) and ready to show it on demand by authorities.
 - b. Bring COVID-19 free health fitness certificate from any registered medical practitioner on arrival at Institute.
 - c. On Exit and the entry point of the institute, undergo AI-powered thermal screening for temperature as required and make entry at the gate with name, mobile number and signature for security reasons.
 - d. Cleaning and fumigation of the institute premises, including hostel will be carried out as per the routine protocols.
 - e. Procure and use an effective hand sanitizer at all contact points appropriately.
 - f. Maintain social distancing while interacting with a person.
 - g. Compulsory wearing of COVID-19 protective gear such as mask and hand gloves. These are to be procured by the student.
 - h. On arrival at the institute if you are asymptomatic with direct and high-risk contact with a confirmed case of COVID-19, you should be tested once between day 5 and day 14 after contact and follow the instructions of quarantine as per guidelines of Govt. of Maharashtra/BMC.
 - i. Report to the family physician, institute physician and/or nurse and institute authorities in case of a severe acute respiratory illness (SARI) (fever AND cough and/or shortness of breath) during the stay in the hostel.
 - j. Drink only hot/warm water during the entire stay at Hostel/AYJNISHD(D) premises.

2. Restrictions to be followed during the stay due to COVID-19 Pandemic and other constraints:
- a) Canteen, if available, will be only for takeaway. Seating facility is not available, in order to maintain social distancing.
 - b) All parcels/package or food items or grocery supplies can be ordered between 6 am an 10 pm and to be collected at the gate of the institute. These are to be ordered from nearby hygienic places only.
 - c) Visitors/parents or outsiders are not allowed to visit inside the Institute campus during this examination period.
 - d) All students to leave the hostel on completion of their examinations/viva-voce within 2 days [to arrange return journey /tickets accordingly].
 - e) No vehicle entry or parking permitted inside the campus.
 - f) Quarantine, if needed, will be provided as per the need arises following the norms of BMC/Govt. of India.
 - g) No loitering around in the institute campus during free hours.
 - h) No visit to market/shops permitted during the period of stay.

We assure you that the institute is making the best attempts to ensure all the precautions in view of the pandemic.
